BOARD OF DIRECTORS ORGANIZATIONAL MEETING JANUARY 25, 2024

The initial and organizational meeting of the Falcon's Lair Board of Directors was held at Nancy's Bishop's house, and was called to order at 6:30 p.m. on January 25, 2024. - 1. Approval of Minutes:
- a. Approval of January 4, 2024 minutes. Greg moved to approve, seconded by Rick, motion approved without objection. Scott was not present at that meeting and did not vote.

Priorities:

a. Community Committees: Finance and Covenants Review

The Board discussed their invitation to the community to sign up to help on two committees: the Finance Committee and the Covenants Review Committee. Only one homeowner volunteered, and the Board greatly appreciates her willingness to help with these efforts.

b. Road maintenance and protection.

Discussion was held about the maintenance needs for the roads, to protect our investment and the paving. Bids are being gathered at this time.

c. Culverts.

The Board discussed at length the situation with the damaged and collapsed culverts throughout the subdivision which are resulting in flooding with heavy rains and damage to the roads. Butch Harrison and Greg have been inspecting the culverts and affected areas with a local contractor that handles such repairs, and are working on getting a bid. The Board considers this a priority project, but tabled it to get additional information from the contractor.

d. Lease and Sign.

Nancy reported on the status of the Lease and the Falcon's Lair Community sign. She will contact Windsor as soon as possible to complete these items.

4. <u>Attorney Consultation</u>

The Board discussed the need to consult with its attorney concerning lot mergers and will also send the two delinquent accounts as well.
