TRAILERS, BOATS, RV'S



As the weather gets warmer and summer recreation begins, please remember that the Covenants prohibit storing trailers, boats, RV's etc. on your property for more than two consecutive days out of 10 unless in an enclosed garage. Please be a good neighbor and make

arrangements to store your toys appropriately.

SPRING CLEAN UP

It is time for a good spring cleanup! As members of the Falcon's Lair Community we are all required to keep our



homes and property(s) clean and well maintained. Please make sure to keep your lawn(s) mowed, weeds cut, and have all debris and trash picked up. If your house, doors, shutters, decks, or mailboxes need to be painted or power-washed, please arrange to have that done. The Board will start

emailing letters to community members who are not abiding by the Covenants. We all want a clean, safe, and attractive neighborhood so everyone must do their part.

As you plan these repairs, please remember, prior to any external changes to your home, for example changing the color of your doors or shutters, would require approval from the Architectural Review Board [ARB]. Covenants (Article VII.3), alterations include "repair, improvement, changes in paint color, excavation, changes in grade, or other work which in any way alters the exterior of any property or the improvements thereon.
